| Vendor Spaces | Each space is 12' X 12'. If your tent or unit is larger than 12' multiple spaces must be purchased. Two vendor wristbands are included per day per space. Extra wristbands are available for \$10.00 each per day. All space fees are for the 2-day weekend. No single days accepted. |
| Space Fees | Food Concessionaire - \$200.00 per space Specialty Food - \$125.00 per space |
| Definitions | <u>Food Concessionaire</u> : Products prepared on-site for consumption on-site. <u>Specialty Foods</u> : A narrow food product line that is not produced on-site and not intended to be consumed on-site, such as syrups or salsas. |
| Sampling | All vendors serving prepared foods or samples are required to be in compliance with Loudoun County Health Department regulations. Specialty food vendors serving samples are required to submit a notice to participate and adhere to general principles of food hygiene. |
| Vendor Application | The Food Vendor application is available now. A downloadable version is located on our website, www.bluemontfair.org . |
| New Vendors | Please include a photo of your unit and a copy of your proposed menu with prices. |
| All Vendors | *Prices must be posted for all menu items. *Vendors must be able to take credit cards. *No smoking signs are required. |
| Vendor Insurance | It is the vendor's responsibility to give us proof of liability insurance. Please ask your insurance carrier to provide us with a Certificate of Insurance (COI) listing the "Bluemont Citizens Association" as Additionally Insured/Certificate Holder, specifying the following address: PO Box 362, Bluemont, VA 20135. Please refer to our website under "Vendor/Exhibitor Insurance" to ensure you meet the requirements. <u>Your application is not complete until we have received your COI.</u> |
| Generators | We will not allow generators that produce excessive amounts of noise or exhaust. If you will be using a generator, please note this on the application. If we discover your generator is too loud, or causing excessive exhaust, we reserve |

the right to ask you to move to another space or leave the fair. No fees will be reimbursed.

| Application Deadline | Completed application packages must be received by July 1, 2025 to participate in the publicity plan. No refunds for any reason after July 30, 2025. |
| Confirmation | You will be notified by email once a decision has been made, but no later than July 15, 2025. |

| Space Assignment | You will receive an August mailing that includes your space assignment, map and parking tag. Vendor wristbands will be distributed during your set-up. Every effort will be made to assign spaces so that similar foods are not adjacent. However we cannot guarantee that there will not be any overlap, especially in regards to drinks and desserts. |
| Set Up | <p>Space assignments at the <u>Bluemont Community Center (BCC) Only</u>: Friday, September 19–6:30 PM to 8:00 PM Saturday, September 20–8:00 AM to 9:00 AM <i>The BCC parking lot will be used for the pickup of children on Friday evening until 6:30 PM. If you arrive early please DO NOT enter the BCC driveway. Proceed to the parking area (Plaster’s Field) and queue up until 6:30.</i></p> <p>Space assignments at <u>all other locations</u>: Friday, September 19 – 4:00 PM to 8:00 PM Saturday, September 20 – 8:00 AM to 9:00 AM Note: Food Inspection will start at 9:30 AM on Saturday.</p> |
